To apply for a Scholarship, complete the entire application packet, this includes:

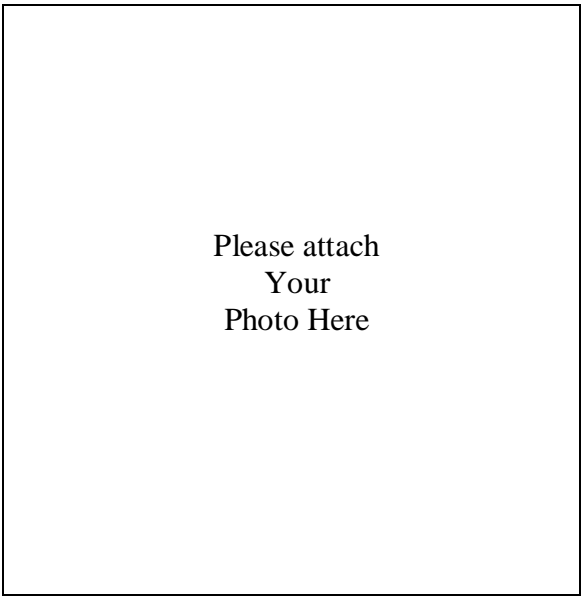
- Application form (attach list of activities, honors, awards, work experience, etc.)

Essay Assignment

Describe the importance of good financial planning and your future. Provide an example of how good (or bad) financial planning has affected your life. Consider such questions as: How do you accomplish it? What steps would you take to establish a good credit history? How can owning a car, going to college, or spending effect your decisions? How can ECCU help you?

Judges will consider such criteria as:

- **Content:** Does the essay address the assigned topic? Is it clear and focused?
- **Organization:** Does the structure of the essay make it easy to read and understand?
- **Writing Basics:** Does the writer demonstrate a knowledge of conventional writing (grammar usage, spelling, punctuation, etc.)?

Essays should be 300 to 500 words and must be typed and double-spaced.
